### PARTICIPANT DECLARATION

With regard to my participation in the project entitled: „*Establishment and Implementation of Interdisciplinary, Internationally-Oriented PhD Studies in English at the Faculty of Medicine, Ludwik Rydygier Collegium of Nicolaus Copernicus University*” I herein represent and acknowledge that:

1. My personal data is administered by the Minister of Development, serving as the Administrative Institution for the Knowledge Education Development 2014-2020 Operational Program, located at pl. Trzech Krzyży 3/5, 00-507 Warsaw.

2. c) The Act of 11 July 2014 on provisions of implementing cohesion policy programs financed within the 2014-2020 financial framework (Journal of Laws item 1146 as amended);

2) Central ICT system supporting the implementation of operational programs:

a) The EU Regulation No 1303/2013 of the European Parliament and of the Council of 17 December 2013, laying down common provisions on the European Regional Development Fund, the European Social Fund, the Cohesion Fund, the European Agricultural Fund for Rural Development and the European Maritime and Fisheries Fund and laying down general provisions on the European Regional Development Fund, the European Social Fund, the Cohesion Fund and the European Maritime and Fisheries Fund, and repealing Council Regulation (EC) No 1083/2006,

b) The EU Regulation No 1304/2013 of the European Parliament and of the Council of 17 December 2013 on the European Social Fund, and repealing Council Regulation (EC) No 1081/2006,

c) Law of 11 July 2014 on provisions of implementing cohesion policy programs financed within the 2014-2020 financial framework,

d) Commission Implementing Regulation (EU) No 1011/2014 of 22 September 2014 laying down detailed rules for implementing Regulation (EU) No 1303/2013 of the European Parliament and of the Council as regards the models for submission of certain information to the Commission, and detailed rules concerning information exchange between beneficiaries and managing authorities, certifying authorities, audit authorities and intermediate bodies (Official Journal L 286, 30.9.2014, p. 1).
